Certified Seed Potato Bin Hygiene Declaration

OFFICE USE

A seed potato bin hygiene declaration statement is recommended when certified seed potatoes are packed into **USED** bins or **BULK TRUCKS**. The completion of the bin hygiene declaration relates to on-farm biosecurity, especially seed potato farms. Ensuring seed bins and bulk trucks that are used to hold certified seed potatoes are clean and practically free of soil, potatoes and other plant material limits the transfer of pests and diseases, particularly restricted or quarantinable pests and diseases. Importantly, clean bins assist in maintaining the quality of certified seed potatoes. AuSPICA strongly supports certified seed potato growers requesting that clean bins are supplied.
